
## 1 Evaluation of the notifications in Safefood Online 2021



### 1.1 Notifications, in total

---

With 871 notifications the number of notifications (RASFF notifications and EU-Monthly Summary of Articles on Food Fraud and Adulteration) has increased in 2021 by 22% to 4885 notifications (compared to 2020) and is at the highest level since starting the recording in Safefood Online:






## 1.2 hazards


The increase in the number of notifications is mainly due to 2 hazards we have been reporting several times in 2021:

### **Ethylene Oxide/ 2-Chloroethanol (ETO) and Chlorpyrifos (with Chlorpyrifos-Ethyl and Chlorpyrifos-Methyl).**

In total 891 notifications for both hazards in 2021 are reported. The two hazards are in second and third place behind notifications regarding Salmonella:




### ETO-notifications by food:




By far the most ETO notifications are linked to sesame seeds (95). If the notifications on processed sesame products are added, there were in total 117 notifications. The number of notifications may even be somewhat higher, since for some foodstuffs only the group, e.g., bakery products, was indicated and

possibly also findings in sesame products may have led to the notification. There were also



many notifications on food supplements (45 reports), locust bean gum (E 410) with 28 notifications, ice cream with 24 notifications). There were 10 notifications for guar gum (E412). To complete the picture, we would like to add that ice cream was so often mentioned because ingredients contained therein (such as stabilizers) were treated with ETO.


### Chlorpyrifos-notifications by food:



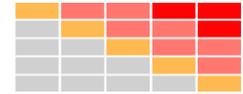
The most notifications for chlorpyrifos or chlorpyrifos-ethyl and chlorpyrifos-methyl were for oranges, mandarins and paprika.

The following graphic presents the notifications according to the hazard categories:





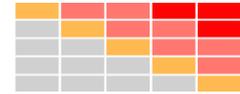
The hazard categories pesticide residues (with ethylene oxide and chlorpyrifos) and pathogenic micro-organisms are far ahead of the notifications on adulteration/ fraud, mycotoxins and composition.


The following tables are showing the TOP 10 products and product categories by number of notifications:

The development of the notifications by type of notification compared to the previous year is shown in the following graphic:




Changes have been noted in particular for "border rejection notifications" (+409 reports) and "information notifications for observation" (+320 reports).


### 1.6 Notifications according to the country of origin


Finally, the notifications are presented by country of origin. From 177 of 4885 notifications in the Safefood-Online database 2021, the origin of the products is not known or several countries of origin are indicated. These notifications are not included in the evaluation below. Of the 4885 notifications, 1924 (39,4%) originated within the EU and 2784 (57.0%) outside the EU.

Among the EU countries, notifications of articles from Poland, France and Spain are in the lead:





## notifications ( $\geq 10$ ) with country of origin = EU





Most notifications from non-EU countries originate as in 2020 from Turkey, India and China, with India and Turkey switching places in 2021 compared to 2020. In 2020, there were 457 notifications originating from India and 372 notifications originating from Turkey; in 2021, there are a total of 552 notifications originating from Turkey and 333 notifications originating from India:

In December 2021, further amendments to pesticide MRLs were published in [Regulation \(EU\) 2021/2202](#):



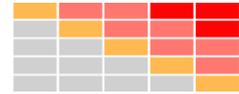
